## Teens Against Dating Violence Advisory Board Frequently Asked Questions

### How can you be part of the Teens Against Dating Violence (TADV) Advisory Board?

The TADV Advisory Board recruits and selects new members each year. Applications to serve as a member for the 2017-2018 school year must be submitted by September 1<sup>st</sup>, 2017 by 5 p.m. Please reserve your calendar from 11 a.m. to 5 p.m. on September 9<sup>th</sup>, 2017 and September 23<sup>rd</sup>, 2017 (Saturdays) for potential interview and meeting dates. If unavailable on one or both days, please note on submitted application or in email correspondence (see "How do you apply?" below).

### What are the requirements?

1. You must be alcohol, tobacco and drug free and committed to promoting a positive, healthy lifestyle free of violence.
2. You must be at least 15 years old and enrolled in school or have graduated high school.
3. You must be willing to commit to the TADV Advisory Board for at least one school year (September 2017 – April 2018).
4. You must complete a parental permission form if you are under 18 years old.
5. You must be creative and have writing skills or knowledge of social media.

### What does the TADV Advisory Board do? Duties include the following:

- Meet quarterly (in person) and communicate digitally on a weekly basis (as needed).
- Contribute to the Facebook, Twitter, and Instagram social media platforms.
- Promote the Teen Dating Violence Prevention Program and its social media platforms with peers.
- Advise the Partnership Against Domestic Violence (PADV)'s Annual 2018 Teen Summit planning committee.
- Shadow, and subsequently co-facilitate, at least one Teen Dating Violence 101 presentation in addition to attending in-person quarterly meetings.

### What are the benefits from being part of the TADV Advisory Board?

5. Use skills and creativity for the enhancement and promotion of PADV Teen Scene.
6. Remain enrolled in school and fulfill academic obligations.
